## WHAT IS STARS OVER TMI?

Stars Over TMI gala and auction is an elegant and fun party with a purpose! Started in 1995 by '98 parent of alumni, Jerilyn Blanchard, and a small group of parent volunteers, Stars Over TMI was held outdoors on campus on what we refer to as "Stars Lawn" located in front of the Frost Athletic Building. Today, the event has grown to be TMI's largest and most important fundraising event that fosters community and support from families, alumni, faculty, staff, parents of alumni, grandparents, business partners and friends of our school.

Every year proceeds from the event go toward annual giving, which supports the operating budget, and helps close the 'gap' between tuition and the actual cost of a TMI education. Monies raised from Stars Over TMI impact all aspects of TMI from student life, programs, professional development, technology, grounds, and facilities and more.

A planning committee of dedicated volunteers and staff work together in creating a memorable and meaningful event. Leading our volunteer committee this year are Stars Over TMI Event Chairs, Ixchell Gonzalez, Parent of Anom '25 and Ale '28 and Teresita Tejada, Parent of Kaily '25.

This year's 2025 Stars fundraiser will include an online auction March 27-April 3 and a gala, super silent online auction, live auction & raffle on Saturday, April 5 from 5:30-9:00 p.m. at the La Cantera Resort & Spa. Live music performed by Finding Friday will follow.
